IT IS SPECIFICALLY UNDERSTOOD BY LICENSEE AND MYSELF THAT THIS RELEASE IS INTENDED TO AND DOES RELEASE LICENSOR FROM ALL CLAIMS AND CAUSES OF ACTION, INCLUDING ALL LIABILITY FOR INJURIES, DEATH, OR DAMAGE ARISING OUT OF THE NEGLIGENCE OR GROSS NEGLIGENCE OF LICENSOR, LICENSOR'S MEMBERS, MANAGERS, OFFICERS, OWNERS AND PARTNERS, OR ANY OTHER PERSON OR ENTITY.

Indemnity

I FUTHER HEREBY AGREE TO INDEMNIFY AND HOLD LICENSOR AND ITS MEMBERS, MANAGERS, OFFICERS, OWNERS AND PARTNERS HARMLESS FROM ANY CLAIMS OR ACTIONS BASED ON OR ARISING OUT OF INJURIES, INCLUDING DEATH, TO PERSONS OR DAMAGES TO OR DESTRUCTION OF PROPERTY, SUSTAINED OR ALLEGED TO HAVE BEEN SUSTAINED IN CONNECTION WITH OR TO HAVE ARISEN OUT OF OR INCIDENTAL TO THE PREFORMANCE OR EXERCISE OF THIS LICENSE TO HUNT BY MINOR, INCLUDING REASONABLE AND NECESSARY ATTORNEYS FEES, COSTS AND EXPENSES INCURRED BY LICENSOR IN DEFENSE OF ANY OF SAME. THIS INDEMNITY IS MADE REGARDLESS OF WHETHER SUCH CLAIMS OR ACTIONS ARE FOUNDED IN WHOLE OR IN PART UPON ALLEGED NEGLIGENCE OR GROSS NEGLIGENCE OF LICENSOR, AND/OR ITS MEMBERS, MANAGERS, OFFICERS, OWNERS AND PARTNERS FROM AND AGAINST ANY LAWSUITS, CLAIMS, DEMANDS, DAMAGES, CLAIMS FOR ATTORNEY'S FEES, AND ATTORNEY'S FEES ARISING FROM MINOR'S EXERCISE OF THIS LICENSE TO HUNT BY MINOR.
